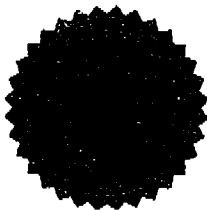

**CERTIFICATE OF AMENDMENT OF THE
THIRD AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
GOPIN INC.**

Pursuant to Section 242
of the General Corporation Law of
the State of Delaware

GoPin Inc., formerly known as K&B Networks Inc. (hereinafter called the "Corporation"), organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

1. The Corporation filed its original Certificate of Incorporation with the Secretary of State of the State of Delaware on May 15, 1998. The Corporation filed its First Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on October 26, 2000, filed its Second Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on May 29, 2001, and filed its Third Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on November 16, 2001.

2. At a meeting of the Board of Directors of the Corporation on April 10, 2002, resolutions were adopted setting forth a proposed amendment of the Third Amended and Restated Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and calling a meeting of the shareholders of said Corporation for consideration thereof. Thereafter, the stockholders of the Corporation entitled to vote in respect thereof duly approved said proposed amendment by written consent by a vote of the necessary number of shares in accordance with the Third Amended and Restated Certificate of Incorporation of the Corporation and Sections 228 and 242 of the General Corporation Law of the State of Delaware.

The Third Amended and Restated Certificate of Incorporation of the Corporation is hereby amended so that the First Article shall be and read as follows:

FIRST: The name of the Corporation is: I4 Commerce Inc.
