Assignor hereby authorizes Assignee to apply for and obtain the recordation of this Assignment.

Assignor hereby represents and warrants that he has the full right to convey the entire interest herein assigned, that there are no rights and interests outstanding inconsistent with the rights and interests granted herein, and that Assignor shall not execute any instrument or grant or transfer any rights or interest inconsistent herewith.

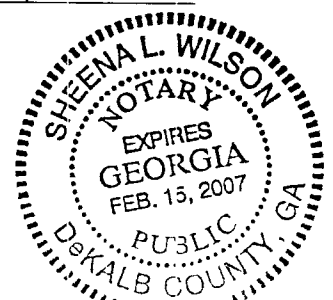
