Assignor hereby authorizes and requests that the Director of the U.S. Patent and Trademark Office issue any and all service marks issued pursuant to the Rapfinity Application to ChoicePoint Asset Company, for its sole use and behoof; and for the use and behoof of its legal representatives, to the full end of the term for which said Service Mark may be granted, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made. By executing this assignment, Assignee assumes all of the rights, benefits, obligations and liabilities associated with the Rapfinity Application and any Service Mark registration issued pursuant to the Rapfinity Application by the USPTO.
