Assignor does hereby assign, transfer and convey to Assignee, its successors, assigns and legal representatives, all of Assignor's rights, title and interest in and to the Trademark, including all common law rights therein, together with the goodwill of the business symbolized thereby, and including without limitation Assignor's right to sue for and seek remedies against past, present and future infringements of the Trademark, and rights of priority and protection of interests therein under the laws of any jurisdiction, free and clear of any liens, claims, security interests, and other encumbrances.

2. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the United States of America and of the State of Georgia.

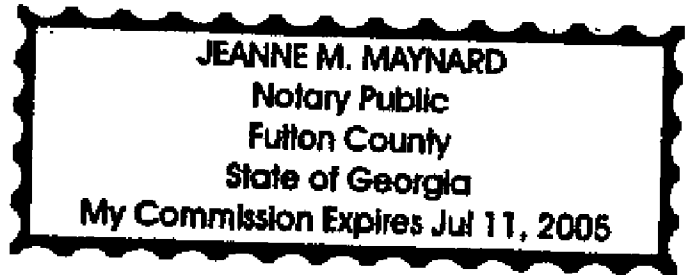
3. Successors and Assigns. This Assignment shall inure to the benefit of and be binding on the successors and assigns of both parties.
