




**- CERTIFICATE OF AMENDMENT**  
**OF**  
**ARTICLES OF INCORPORATION**  
**OF**  
**FTS SYSTEMS, INC.**

Under Section 805 of the Business Corporation Law

The undersigned being respectively the president and the assistant secretary of FTS Systems, Inc., a New York Corporation, hereby certify as follows:

1. The name of name the corporation is FTS Systems, Inc.
2. The Certificate of Incorporation of FTS Systems, Inc. was filed by the Department of State on November 30, 1970. Certificates of Amendment of the Certificate of Incorporation of FTS Systems, Inc. were filed by the New York Department of State on April 3, 1974, December 18, 1989, and on November 29, 1996, respectively and a Certificate of Merger of Farnham Holdings, Inc. into FTS Systems, Inc. was filed by the New York Department of State on November 18, 1996 which amended the Certificate of Incorporation of FTS Systems, Inc. (the Certificate of Incorporation and all amendments thereto are collectively referred to here in as the "Certificate of Incorporation").
3. The Certificate of Incorporation of FTS Systems, Inc. is hereby further amended so as to change the name of the corporation to Kinetics Thermal Systems, Inc.
4. Paragraph 4 of the Certificate of Incorporation shall be amended to read as follows:  
 " 1. The name of the corporation is Kinetics Thermal Systems, Inc."
5. The amendment of the Certificate of Incorporation were authorized by a unanimous vote of the holders of all outstanding shares entitled to vote thereon and were also approved by unanimous vote of all of the Board of Directors.
