Agreement on contribution to capital

be taken on record and notarized:

I.**Preliminary remarks**

Prof. Dr. h.c. Hartmut Esslinger is carrying on a sole proprietorship under the name of frogdesign Hartmut Esslinger, having its seat in Altensteig. The assets of the sole proprietorship include among other things a piece of land and a company interest.

Prof. Dr. h.c. Hartmut Esslinger and H.E. Verwaltung GmbH i.G. have established a limited partnership under the name of Esslinger GmbH & Co. KG. In his capacity as limited partner of that company, Prof. Dr. h.c. Hartmut Esslinger makes his compulsory contribution according to Art. 2, para. 2, of the Partnership Agreement of Esslinger GmbH & Co. KG by contributing his sole proprietorship, with its assets and liabilities according to the German Tax Law on the transformation of companies (UmwStG). Now, therefore, the following is herewith agreed:

II.

Contribution

1. Prof. Dr. h.c. Hartmut Esslinger contributes to Esslinger GmbH & Co. KG i.G., and the latter herewith accepts, his sole proprietorship known as frogdesign Hartmut Esslinger with the following assets and liabilities, at the book values determined for tax on income purposes on Dec. 31, 1999, 12.00 p.m.:

a) Transferred assets:

aa) The piece of land located at Grenzweg 33,
parcel 1453/1, with building and open space 12,70 ares,

recorded in the land register of Altensteig, vol. 11458.

Division II of the land register shows no charges on the land mentioned above. The land charges recorded in Division III of the land register in favor of Volksbank Altensteig e.G. are taken over by Esslinger GmbH & Co. KG i.G.

The ownership, benefits and burden with respect to the piece of land mentioned above is transferred by contract with effect from Jan. 1, 2000.

Prof. Dr. h.c. Hartmut Esslinger and Esslinger GmbH & Co. KG i.G. are in agreement with respect to the transfer of the title to the before-mentioned land to Esslinger GmbH & Co. KG i.G.; Prof. Dr. h.c. Hartmut Esslinger consents

to, and Esslinger GmbH & Co. KG i.G. requests, the entry of the change in title in the land register.

- cc) Also assigned are the remaining assets of the sole proprietorship known as frogdesign Hartmut Esslinger, consisting of
- intangible assets;
 - plant and machinery;
 - other fixtures and fittings, tools and equipment;
 - the current assets;
 - the rights underlying the accruals items;

as they appear from the balance-sheet per Dec. 31, 1999. The transfer shall take effect by contract on Jan. 1, 2000, giving due regard to all additions and reductions that occurred after that date in the course of normal business management.
