## ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS; dated as of July 28, 1999, is entered into by and between Fearnow Bros., Inc., a Virginia corporation ("Assignor"), and Castleberry's Food Company, a Georgia corporation ("Assignee").

Assignor is the exclusive owner of all of the right, title and interest in and to, and has adopted, used and is using the trademarks set forth in Exhibit A attached hereto (the "Marks").

Assignor has been issued the trademark registrations set forth in Exhibit B attached hereto by the U.S. Trademark Office (the "Registrations").


Assignor desires to transfer to Assignee, and Assignee desires to acquire from Assignor, the Marks and the Registrations, together with the goodwill of the business symbolized by the Marks.

NOW THEREFORE, for and in consideration of the covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby conveys, sells, transfers, assigns and delivers to Assignee, its successors and assigns, all the right, title and interest of Assignor in and to the Marks and the Registrations, together with the goodwill of the business symbolized by the Marks.
2. Assignee shall have all right to register, extend, renew, maintain, defend and enforce the Marks and the Registrations in its own name in the United States and any foreign country, and Assignor hereby agrees, at Assignee's sole cost and expense, to execute any documents and perform any acts to enable and assist Assignee to register, extend, renew, maintain, defend and enforce the Marks and the Registrations and to confirm or record this assignment in the United States and any foreign country.
3. Assignor hereby assigns to Assignee, its successors and assigns all causes of action and claims of infringement of the Marks under the trademark laws of the United States, foreign countries and international trademark conventions and treaties that have accrued to Assignor as of the date hereof.
4. This Assignment is executed and delivered in conjunction with that Asset Purchase Agreement between the parties and others, dated July 26, 1999.
5. Assignor hereby agrees that this Assignment shall be binding upon its successors and assigns.
