This Assignment has been executed at Minneapolis, MN on November 1, 2004.

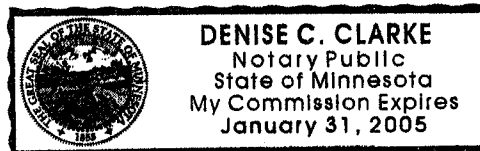
