**ACKNOWLEDGEMENT OF
TERMINATION OF SECURITY AGREEMENT**

This Acknowledgment of Termination of Security Agreement (the “**Acknowledgement of Termination**”) is made and entered into as of December 15th, 2004, by and among Elumens Corporation, a Delaware corporation (the “**Company**”), and Southeast Interactive Technology Funds III, LP, Southeast Euro Interactive Technology Funds III, LP, Southeast Interactive Affiliates Funds III, LP, Newlight Associates, LP and Newlight Associates (BVI), LP, (the “**Secured Parties**”) .

W I T N E S S E T H

WHEREAS, the Company and the Secured Parties entered into a Security Agreement, dated April 29, 2002 (the “**Security Agreement**”);

WHEREAS, Section 1 of the Security Agreement provides for the termination of the Security Agreement; and

NOW, THEREFORE, the Company and the Secured Parties hereby agree as follows:

1. The Security Agreement was hereby terminated in all respects on March 5th, 2004.
2. The Secured Parties shall execute, deliver, and file all documents and take all actions necessary to terminate and release the Secured Parties’ lien on the “**Collateral**” (as defined in the Security Agreement), including, without limitation, executing and filing a Notice of Recordation of Termination of Security Agreement with the U. S. Patent and Trademark Office.
3. This Acknowledgment of Termination may be executed in two or more counterparts, each of which shall be deemed to be an original and all of which shall together constitute one and the same instrument.
4. This Acknowledgment of Termination shall be governed by the laws of the State of North Carolina, other than its rules with respect to choice of law.

IN WITNESS WHEREOF, the Company and the Secured Parties hereto have executed this Acknowledgment of Termination Agreement effective as of the date first above written.


