ASSIGNMENT OF TRADENAME AND TRADEMARK

THIS ASSIGNMENT is made this ___ day of January, 1997, by TWIN MOUNTAIN ROCK COMPANY, a New Mexico corporation ("Assignor"), to WESTERN ORGANICS, INC. ("Assignee").

PRELIMINARY STATEMENT. Assignor has certain rights in the tradename "Eco-Lite" (the "Tradename") and the trademark thereon, evidenced by the Certificate of Registration filed with the United States Patent and Trademark Office (the "Trademark"), a copy of which is attached hereto as Exhibit A. Assignee desires to acquire the entire interest of Assignor in the Tradename, including the Trademark.

NOW THEREFORE, conditioned upon the receipt by Assignor of payment of \$3,000 from Assignee, Assignor assigns, sells, conveys, transfers and delivers to Assignee, its successors and assigns, absolutely and forever, all of its entire and unrestricted right, title and interest, domestic and foreign of Assignor, in and to the Tradename and in the Trademark, including, without limitation, all goodwill associated therewith, the right to secure the trademark thereon throughout the entire world, and to hold said Tradename and Trademark and all rights whatsoever nature thereunder existing.

The Assignor hereby represents and warrants that it has not previously assigned, transferred, conveyed, or otherwise encumbered, and that it will not further attempt to sell, assign, or transfer, such right, title and interest as it conveys to Assignee under this Assignment.

The Assignor hereby agrees for itself, its, successors and assigns, to execute any and all documents and to perform any and all acts which Assignee, its successors and assigns, may deem necessary to secure thereto the rights herein assigned, sold and transferred.
