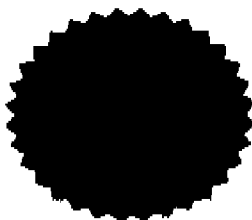


- 1. The name of the limited liability company (hereinafter called the "limited liability company") is **Embroidery Acquisition LLC**.
