## ASSIGNMENT OF TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that **INFORMATION MANAGEMENT SYSTEMS, INC.**, a Florida corporation (“Seller”), and **INNOVATIVE HEALTH SOLUTIONS, LLC**, a New Jersey limited liability company (the “Buyer”) have entered into an Asset Purchase Agreement dated as of December 21, 2004, pursuant to which Seller agreed to sell and Buyer agreed to buy substantially all of the assets of Seller (the “Agreement”). ### W I T N E S S E T H:

WHEREAS, in accordance with the Agreement, Seller has simultaneously herewith by a bill of sale, assignments and other instruments of transfer and conveyance of even date vested in Buyer all of Seller’s right, title and interest in the Acquired Assets effective as of Closing Date; and

WHEREAS, Seller has adopted, used and is the owner of the trademarks which are pending and registered in the United States as listed on Exhibit A annexed hereto and made a part hereof (the “Trademarks”); and

WHEREAS, Buyer is desirous of acquiring the entire right, title and interest in the Trademarks and the issued registrations thereof.

NOW THEREFORE, in consideration of the mutual promises contained herein, and for other good and valuable consideration, Buyer and Seller agree as follows:

1. Seller, by these presents, does sell, assign, and transfer unto the Buyer the entire right, title and interest in and to the Trademarks and the issued registrations thereof, together with the good will of the business symbolized by said marks and issued registrations thereof.

2. Seller, at the expense of Buyer, agrees to execute all other instruments and take all other lawful actions necessary or appropriate to assist Assignee in securing and maintaining registered trademarks in the United States as the Buyer shall designate, and to vest and confirm in the Buyer legal title to the pending and registered trademarks and the issued registrations thereof.
