It is hereby certified that:

1. The name of the corporation is National Applied Computer Technologies (the "Corporation").

2. The amendment of the restated articles of incorporation effected by this certificate of amendment is to change the name of the Corporation.

3. To accomplish the foregoing amendment, Article I of the restated articles of incorporation, relating to the name of the Corporation, is hereby stricken out in its entirety, and the following new Article I is substituted in lieu thereof:

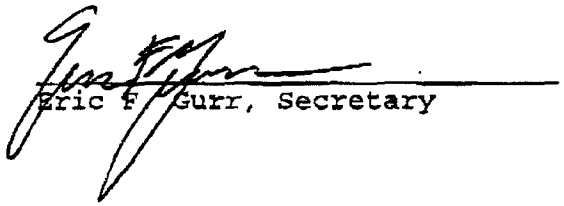
