


The undersigned being respectively the vice president and the assistant secretary of Kinetics Thermal Systems, Inc., a New York Corporation, hereby certify as follows:

1. The name of name the corporation is Kinetics Thermal Systems, Inc.
2. The Certificate of Incorporation of Kinetics Thermal Systems, Inc. was filed by the Department of State on November 30, 1970. Certificates of Amendment of the Certificate of Incorporation of Kinetics Thermal Systems, Inc. were filed by the New York Department of State on April 3, 1974, December 18, 1989, November 29, 1996, and on March 15, 2001 respectively and a Certificate of Merger of Farnham Holdings, Inc. into Kinetics Thermal Systems, Inc. was filed by the New York Department of State on November 18, 1996 which amended the Certificate of Incorporation of Kinetics Thermal Systems, Inc. (the Certificate of Incorporation and all amendments thereto are collectively referred to here in as the "Certificate of Incorporation").
3. The Certificate of Incorporation of Kinetics Thermal Systems, Inc. is hereby further amended so as to change the name of the corporation to FTS Systems, Inc.
4. Paragraph 4 of the Certificate of Incorporation shall be amended to read as follows:
"1. The name of the corporation is FTS Systems, Inc."
5. The amendment of the Certificate of Incorporation were authorized by a unanimous vote of the holders of all outstanding shares entitled to vote thereon and were also approved by unanimous vote of all of the Board of Directors.
