3. The Articles of Organization of the Company are amended by deleting Article I in its entirety and inserting the following section in its place and stead:

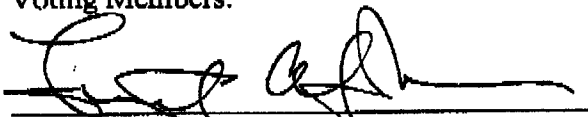
**ARTICLE I**  
**Name and Duration**

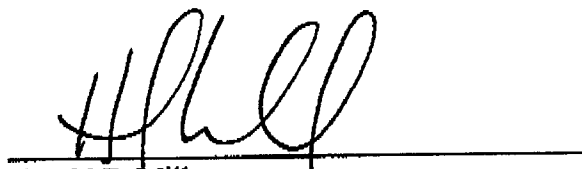
