These limitations shall apply notwithstanding any failure of essential purpose and applies to all causes of action in the aggregate including, without limitation, breach of contract, breach of warranty, negligence, strict liability, misrepresentation, and other torts.

In no event shall the aggregate liability of Assignors arising under or in connection with this Assignment (or any breach or violation hereof) or the transactions contemplated hereby exceed five thousand dollars (\$5,000). Such limitation is an essential provision of this Assignment.
