THIS AGREEMENT is made on 14th August 2003 between the following parties

- (1) **WESTON MEDICAL GROUP PLC**, in administration, with registered number 3904994, whose registered office is at Aquis Court, 31 Fishpool Street, St Albans, AL3 4RF ("PLC") acting by its administrators Allan Watson Graham and Jane Bronwen Moriarty both licenced insolvency practitioners of KPMG LLP (the "Administrators")
- (2) **WESTON MEDICAL LIMITED**, in administration, with registered number 2865476, whose registered office is at Aquis Court, 31 Fishpool Street, St Albans, AL3 4RF ("Limited") (Limited and PLC, together the "Assignor") acting by its administrators Allan Watson Graham and Jane Bronwen Moriarty both licenced insolvency practitioners of KPMG LLP
- (3) **THE ADMINISTRATORS** in their respective capacities as Administrators of the Sellers
- (4) **ARADIGM CORPORATION** a corporation established under the laws of the state of California, having its principal place of business at 3929 Point Eden Way, Hayward, California, CA 94545 (the "Assignee")

BACKGROUND

- (A) By orders of the Chancery Division of the High Court dated 28 February 2003 in proceedings number 1422 and 1423 of 2003 it was ordered that the Administrators be appointed joint administrators of the Sellers, with power to act either jointly or severally, for the purposes set out in the orders (the "Administration").
- (B) The Assignor is the proprietor of the trade marks registered or the subject of applications for registration in the countries listed in the Schedule to this Agreement ("Trade Marks")
- (C) The parties entered into an agreement for sale of certain assets including the Patents on 12 May 2003 ("Asset Purchase Agreement").
- (D) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out in the Asset Purchase Agreement and this Agreement.

1. AGREED TERMS

- 1.1 In return for the Consideration as set out in clause 6 of the Asset Purchase Agreement (receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee all right title and interest as the Assignor has in the following:
 - 1.1.1 the Trade Marks;
 - 1.1.2 the benefit of the applications for registration with the intention that when the applications are granted the registrations will vest in the Assignee; and
 - 1.1.3 any common law rights and all the goodwill attaching to the Trade Marks.

- 1.2 This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks).
- 1.3 The Assignor hereby covenants with the Assignee that Assignor will at the expense of the Assignee execute sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee or its nominee to enjoy the full benefit of the rights hereby assigned.
- 1.4 This assignment shall be governed by and construed in accordance with the laws of England. The parties hereto submit to the exclusive jurisdiction of the English courts.
- 1.5 Expressions defined in the Asset Purchase Agreement shall have the same meaning in this Agreement (unless the context otherwise requires or a term is redefined or amended in this Agreement).
- 1.6 The schedules form part of this Agreement and shall be construed and shall have the same full force and effect as if expressly set out in the body of this Agreement and any reference to this Agreement shall include the schedules.
- 1.7 The headings are inserted for convenience only and shall not affect the construction of this Agreement.


