Antibiotics, hormones, and cytostatic agents for use in the treatment of bone loss, fractures, infections, osteoporosis, cancer, wound management, tissue regeneration; food for medically restricted diets; food for babies; medical plasters, dressing materials for wounds, burns, tissue defects after trauma, trauma surgery, orthopedics, crania-facial-defects, esthetic surgery; materials for stopping teeth; bone cement for medical purposes and substitute materials for bone cements for medical purposes; dental wax; all-purpose disinfectants; preparations for destroying vermin; fungicides and herbicides for domestic and agricultural use in International Class 05.


Bone implants; devices for injecting bone cement and pharmaceutical preparations and other medical materials into the human and animal body, namely syringes including multichamber syringes, application devices including pharmaceutical carriers in solid or fluid form; artificial limbs, eyes, and teeth; orthopedic articles for use with prostheses and artificial limbs, eyes, and teeth, namely wedges, cages for spinal applications, spacer, solid implants, pastes, granules; suture materials in International Class 10.
