To the United States Patent and Trademark Office

Dear Sir or Madam:

Please be advised that pursuant to the Security Agreement and Assignment of Patents, Trademarks and Other Intellectual Property (the "Security Agreement"), dated as of June 1, 2004, by and among PRODUCTION CONTROL SERVICES, INC., a Colorado corporation ("PCS"), PRODUCTION CONTROL SERVICES GROUP, INC., a Delaware corporation ("PCSG") (collectively, the "Original Borrowers"), and COLORADO BUSINESS BANK (the "Lender"), the Original Borrowers granted to the Lender a continuing, first priority security interest in and continuing lien upon, the trademark registrations and trademark applications set forth on Exhibit A attached hereto and incorporated herein by this reference (collectively, the "Trademarks").

Subsequent to the date of the Security Agreement, PCS merged with and into PCSG, with PCSG as the surviving corporation (the "Merger"). In connection with the Merger, PCSG changed its name to Production Control Services, Inc., a Delaware corporation (the "Surviving Borrower").

The Surviving Borrower and the Lender hereby acknowledge and agree that the continuing, first priority security interest in and continuing lien upon the Trademarks pursuant to the Security Agreement (i) may only be terminated in accordance with the terms of the Security Agreement, and (ii) this Notice shall serve as notification only of the Lender's continuing, first priority security interest in and continuing lien upon the Trademarks, and shall not be construed as a current assignment by the Surviving Borrower to the Lender of any of the Trademarks.

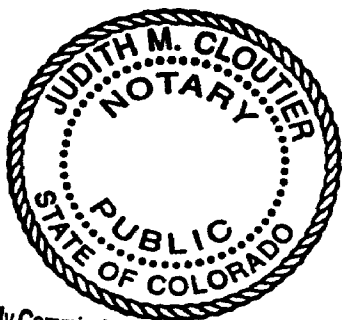
