This Assignment is made this 20th day of April, 2004, by and between DaVita Inc., a Delaware corporation, whose primary business address is 601 Hawaii Avenue, El Segundo, California, 90245, ("Assignor") and Open Access Vascular Access Center, Inc. a Florida Corporation, whose primary business address is 16400 N.W. 2nd Avenue, Suite 101, N. WHEREAS, Assignor, has adopted and used in commerce the trademarks which are registered in the U.S. Patent and Trademark Office, Registration No. 2,195,287, registered October 13, 1998, for the mark OPEN ACCESS, and Registration No. 2,195,371, registered October 13, 1998, for the mark OPEN ACCESS (& Design) (collectively "Marks"); and

WHEREAS, Assignor did obtain a letter from the U.S. Patent and Trademark Office of the United States for the Marks and has adopted and used the Marks in commerce; and

WHEREAS, Assignor has the power and authority to assign the Marks and has committed to assign the Marks pursuant to a Severance Agreement entered into by and between Assignor and Sanford Altman, M.D. on March 14, 2000; and

WHEREAS, Assignee desires to acquire the Marks and the goodwill related thereto; and

WHEREAS, Assignee desires to acquire the entire interest of the Assignor in the Marks and the registration thereof; and

NOW, THEREFORE, for good and valuable consideration the sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:


1. Assignor hereby assigns to Assignee all rights, titles, and interests in the Marks together with the goodwill symbolized by the Marks, as well as the right to sue for and collect damages for past and future infringements effective as of March 14, 2000 ("Effective Date"); and

2. Assignee assumes any and all liabilities associated with the Marks as of the Effective Date and shall indemnify Assignor, its officers, directors, employees and affiliates related to its use from and after the Effective Date. Assignor represents and warrants that it has no actual knowledge of any claims, charges or other liabilities that are outstanding as of March 31, 2004 related to the period after the Effective Date. Assignor shall indemnify Assignee, its officers, directors, employees and affiliates, against any and all liabilities, claims or causes of action related to Assignor's use of the Marks prior to the Effective Date.

3. The Commissioner of Patents and Trademarks is requested to issue the certificate of registration to the Assignee.
