

ASSIGNMENT OF TRADEMARK

ASSIGNOR further agrees that it will execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as ASSIGNEE lawfully may request, to perfect and vest title in the mark in ASSIGNEE or ASSIGNEE'S successors and assigns.


