**TERMINATION OF TRADEMARK AND SECURITY AGREEMENTS OF
FLEET CAPITAL CORPORATION**

This is a Termination of Security Interest, dated as of April 20, 2004, executed by Fleet Capital Corporation, ("Secured Party") as Agent for certain Lenders under that certain Loan and Security Agreement dated August 31, 2001 (the "Loan Agreement") among United Natural Foods, Inc. and certain of its affiliates and subsidiaries (collectively, "Borrowers"), releasing all security interests of the Secured Party in the Trademark Collateral (defined below) owned by Natural Retail Group, Inc. ("Debtor").

Recitals

WHEREAS, Debtor granted Secured Party, as Agent, a security interest in the following Trademarks (a) "Sunsplash Market", U.S. Trademark Registration Number 2248478 and (b) "Village Natural Grocers," registered with the Maryland Secretary of State, Registration Number 1992-52883 (the "Trademark Collateral"), as evidenced by two separate Trademark and Security Agreements, each dated as of August 31, 2001.

WHEREAS, Secured Party has agreed to the termination of Secured Party's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby terminates all of the Secured Party's security interests in the Trademark Collateral.
