**TERMINATION OF TRADEMARK AND SECURITY AGREEMENT OF
FLEET CAPITAL CORPORATION**

This is a Termination of Security Interest, dated as of April 30, 2004, executed by Fleet Capital Corporation, ("Secured Party") as Agent for certain Lenders under that certain Loan and Security Agreement dated August 31, 2001 (the "Original Loan Agreement") among United Natural Foods, Inc. and certain of its affiliates and subsidiaries (collectively, "Borrowers"), releasing all security interests of the Secured Party in the Trademark Collateral (defined below) owned by Borrowers.

Recitals

WHEREAS, pursuant to the Original Loan Agreement, Borrowers granted Secured Party, as Agent, a security interest in certain of their trademarks listed on Exhibit A hereto (the "Trademark Collateral"), as evidenced by various Trademark and Security Agreements, each dated as of August 31, 2001.


WHEREAS, Secured Party has agreed to amend and restate the Original Loan Agreement with the Amended and Restated Loan and Security Agreement dated as of the date hereof, under which Borrowers are not required to provide a security interest in the Trademark Collateral.

WHEREAS, Secured Party has agreed to the termination of Secured Party's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby terminates all of the Secured Party's security interests in the Trademark Collateral.

IN WITNESS WHEREOF, Secured Party has caused this Termination of Security Interest to be duly executed on the date first mentioned above.


