**SECURITY INTEREST TERMINATION**

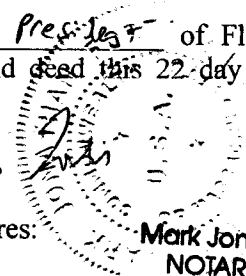
