RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks ("Release") is dated as of December 23, 2004. Reference is hereby made to that certain Amended and Restated Security Agreement dated as of December 23, 2003 by and between PRA International Operations, Inc. (formerly known as PRA International, Inc.) ("Grantor") and Wells Fargo Bank, National Association ("Wells Fargo Bank") as Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Capitalized terms not defined in this Release have meanings set forth for such terms in the Grant of Security (as defined below).

WHEREAS, pursuant to the Grant of Trademark Security Interest, dated as of December 23, 2003 ("Grant of Security"), Grantor pledged to Wells Fargo Bank a security interest in all of its right, title or interest in or to any and all of the Trademark Collateral, including the trademark registrations and trademark applications listed on the attached Schedule A and all proceeds and products of any and all of the foregoing;

WHEREAS, the Grant of Security was recorded in the United States Patent and Trademark Office on December 23, 2003 at Reel/Frame 002769/0384; and

WHEREAS, Grantor has paid and performed in full the Obligations (as defined in the Credit Agreement) and Wells Fargo Bank desires to release its security interest in the Trademark Collateral.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Wells Fargo Bank hereby notifies, acknowledges to and agrees with Grantor that the security interest in the Trademark Collateral granted by Grantor to Wells Fargo Bank pursuant to the terms of the Grant of Security, including, without limitation, the Trademarks listed on the attached Schedule A, is terminated and released as of the date hereof, and that Wells Fargo Bank hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Grant of Security in and to the Trademark Collateral.

Wells Fargo Bank hereby agrees to take such further actions and to execute such further documents as Grantor may reasonably request to effect and evidence this Release of Security Interest in Trademarks, including, without limitation, the execution of any filings, statements, amendments, recordations or other instruments required to maintain the applications or registrations of the Trademark Collateral and record the chain of title accordingly with the United States Patent and Trademark Office.
