

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied.

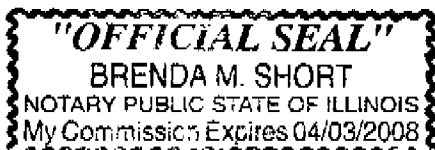
