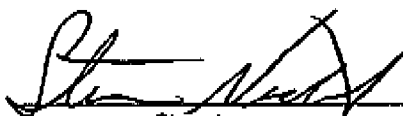

**FIRST AMENDED AND RESTATED
ARTICLES OF INCORPORATION****ENDORSED - FILED**
in the office of the Secretary of State

The undersigned, Jonathon Miller and George Elbaum hereby certify that:

1. They are the duly elected and acting President and Secretary, respectively, of Integrated Linux, Inc., a California corporation.
2. The Articles of Incorporation of this corporation shall be amended and restated to read in full as follows:

"ARTICLE I

The name of this corporation is Threshold Networks, Inc. (the "Corporation").

ARTICLE II

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

ARTICLE III

The Company is authorized to issue only one class of shares which shall be designated Common Stock. The total number of authorized shares shall be 20,000,000 shares. Upon the effective date of the filing of these Amended and Restated Articles of Incorporation, each one (1) share of the Company's outstanding Common Stock shall be converted and reconstituted into ten (10) shares of Common Stock.

ARTICLE IV

- (a) The liability of the directors of the Corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.
- (b) The Corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) to the fullest extent permissible under California law.
- (c) Any amendment or repeal or modification of the foregoing provisions of this Article V by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification."

3. The foregoing amendment has been approved by the Board of Directors of the Corporation.

4. The foregoing amendment has been approved by the holders of the requisite number of shares of the Corporation in accordance with Sections 902 and 903 of the California General Corporation Law. The total number of outstanding shares entitled to vote with respect to the foregoing amendment was 740,000 shares of Common Stock. The number of shares voting in favor of the foregoing amendment equaled or exceeded the vote required. The vote required was more than 50% of the Common Stock.

The undersigned further declares under penalty of perjury under the laws of the State of California that the matters set forth in these Amended and Restated Articles of Incorporation are true and correct of our own knowledge.
