**CERTIFICATE OF AMENDMENT
OF
CERTIFICATE OF INCORPORATION
OF

Pursuant to Section 242
Of the General Corporation Law of
The State of Delaware**

Data Dimensions, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by an unanimous written consent of directors dated December 30, 2002, in accordance with the provisions of Section 141(f) of the General Corporation Law of the State of Delaware, duly adopted a resolution setting forth a proposed amendment to the Certificate of Incorporation, as amended, of the Corporation, to change its corporate name from "Data Dimensions, Inc." to "VeriTest, Inc.", by deleting Article First in its entirety and replacing it with the following:

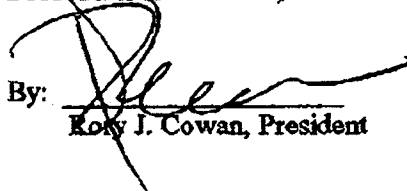
"FIRST. The name of the Corporation is VeriTest, Inc."

and that a Certificate of Amendment of Certificate of Incorporation of the Corporation (the "Charter Amendment") reflecting such amendment, in substantially the form attached hereto as EXHIBIT A, is hereby recommended to the stockholders of the Corporation for their consideration and approval.

SECOND: That the foregoing amendment to the Certificate of Incorporation was duly adopted by the sole stockholder of the Corporation in accordance with the applicable provisions of Section 228 and 242 of the General Corporation Law of the State of Delaware.
