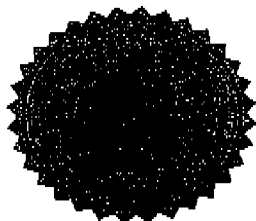

**CERTIFICATE OF AMENDMENT OF
RESTATED CERTIFICATE OF INCORPORATION OF
MARCONI COMMERCE SYSTEMS INC.**

Marconi Commerce Systems Inc., a corporation organized and existing under, and by virtue of, the General Corporation Law of the State of Delaware, does hereby certify:

FIRST: That the Board of Directors has adopted the following amendment to the Restated Certificate of Incorporation of Marconi Commerce Systems Inc. (the "Corporation")

RESOLVED, that the Certificate of Incorporation be amended by replacing Section 1 with the following:

"1. The name of the corporation is Gilbarco Inc."

SECOND: That in lieu of a meeting and vote of the stockholders, the holders of all of the stock of the Corporation have given written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

THIRD: That, the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 228 and 242 of the General Corporate Law of the State of Delaware.
