S. A. (hereinafter referred to as "Amcast") made and enter into this agreement on June 30, 2004.

MIC agrees to assign trademarks and rights of trademarks, including the goodwill associated therewith, to Amcast as described hereunder.

Re: Regarding 1-1, MIC agrees with Amcast that Amcast will salvage this trademark and register it in U. S. A.

2. Value of trademark and payment.

Amcast shall pay to MIC US\$500 for value of two trademarks latest by June 30, 2004.

3. Transfer and salvage procedure of trademarks.

Amcast shall take over transfer and salvage procedure for two trademarks at Amcast's own responsibility and account including recording procedure of the transfer at United States Patent and Trademark Office.

4. Expenses in relation to transfer and salvage trademarks.

Amcast shall bear all expenses of transfer and salvage the rights of two trademarks from MIC to Amcast, both in U.S.A and Japan.

5. Payment from Amcast to MIC.




