OF REGISTERED TRADEMARK**



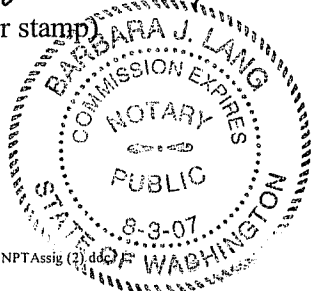


