RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated January 5, 2005 (this "Release") is made by WELLS FARGO FOOTHILL, INC., formerly FOOTHILL CAPITAL CORPORATION, a California Corporation with a place of business at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404 (the "Secured Party") of an Trademark Security Agreement dated March 7, 2001, and recorded on March 12, 2001 in the records of the United States Patent and Trademark Office Assignment Branch at Trademark Reel/Frame 2248/0001 (the "Security Agreement"), between the Secured Party and CHIQUITA BRANDS L.L.C., a Delaware limited liability corporation (as assignee and successor in interest to CHIQUITA BRANDS, INC., a Delaware corporation), referred to herein as the "Debtor;"
