## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of December 21, 2004, is entered into between HERBALIFE INTERNATIONAL, INC., a Nevada corporation ("Assignor"), and MORGAN STANLEY & CO. INCORPORATED, a Delaware corporation ("Assignee"), in its capacity as collateral agent for the lending institutions from time to time party to that certain Credit Agreement, dated as of December 21, 2004, between Assignor, certain of the Guarantors (defined therein), Assignee and such lending institutions. Capitalized terms not otherwise defined herein have the meaning assigned to them in the Security Agreement, dated as of December 21, 2004 (the "Security Agreement"), between Assignor, other pledgors, and Assignee.

WHEREAS, pursuant to the Security Agreement, Assignor is granting to Assignee a security interest in and continuing lien on the Security Agreement Collateral, including registered trademarks and trademark applications.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Grant of Security Interest

(a) Assignor hereby grants to Assignee, for its benefit and for the benefit of the Secured Parties, a security interest in and continuing lien on all Trademarks, including the Trademarks set forth on Schedule A attached hereto, and all of Assignor's right, title and interest in, to and under all of the Trademarks, wherever located, whether now owned or existing, or hereafter arising or acquired from time to time, and the goodwill associated therewith (all of which being hereafter referred to as the "Trademark Collateral").

(b) The security interest granted hereby is granted in conjunction with the security interest and continuing lien granted to Assignee under the Security Agreement, which is deemed incorporated by reference herein. The rights and remedies of Assignee with respect to the security interest and continuing lien granted hereby are in addition to those rights and remedies set forth in the Security Agreement and the other Loan Documents, and those rights and remedies which are now or hereafter available to Assignee as a matter of law or equity. The exercise by Assignee of any one or more of the rights or remedies provided for in this Agreement, the Security Agreement, the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Assignee, of any or all other rights or remedies. In the event that terms of this Agreement conflict with the terms of the Security Agreement, the terms of the Security Agreement shall govern.

2. Modifications of Agreement

Neither this Agreement, nor any provision hereof may be amended, modified, waived, or terminated, except in accordance with Section 7.07 of the Security Agreement. Notwithstanding the foregoing, Assignor authorizes Assignee to file documents with the United States Patent and Trademark Office (or any successor office or any similar office in any other country) for the purpose of modifying this Agreement to the extent that such modification constitutes an amendment of Schedule A hereto to add any right, title or interest in any Trademark Collateral owned or subsequently acquired by Assignor. Assignor additionally agrees to execute any additional agreement or amendment hereto, as may be reasonably required by Assignee from time to time, to subject any such owned or subsequently-acquired right, title, or interest in any Trademark Collateral to the security interest and continuing liens and perfection created or contemplated hereby, or by the Pledge and Security Agreement.

3. Termination of Agreement

Upon payment in full of all the Secured Obligations, or upon any partial release of Trademark Collateral in accordance with the other Loan Documents, the security interests granted shall terminate hereunder and of record, and all rights to the Trademark Collateral shall revert to Assignor, it being understood that in the case of any such partial release, the security interest granted hereby shall terminate hereunder and of record only with respect to such Trademark Collateral subject to such partial release. Upon any such termination, Assignee shall, at Assignor's expense, execute and deliver to Assignor such documents, and takes such other actions, as Assignor reasonably requests to evidence such termination.

4. Governing Law

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAW RULES THAT WOULD RESULT IN A DIFFERENT GOVERNING LAW.

5. Counterparts

This agreement may be executed in any number of counterparts, each of which, when so executed and delivered, shall be deemed an original, but all such counterparts together shall constitute but one and the same agreement.


