Pursuant to the provisions of RCW 23B.10.060, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Milliman USA, Inc.

SECOND: Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

ARTICLE I.
