## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, is entered into as of January 5, 2005 among CHIQUITA BRANDS L.L.C., a Delaware limited liability company (the "Company"), each Person (as defined in the Credit Agreement as defined below) other than the Company which is a party hereto as a Grantor (as defined below) (hereinafter the Company and such other Persons are collectively referred to as the "Grantors" or individually referred to as a "Grantor") and WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as administrative agent (in such capacity, the "Administrative Agent") for itself and the lenders from time to time party to the Credit Agreement described below (the "Lenders").

### RECITALS

A. Pursuant to that certain Credit Agreement dated as of the date hereof by and among the Company, Administrative Agent, the Persons signatory thereto from time to time as Lenders and others (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), Lenders have agreed to make the Loans and to incur Letter of Credit Obligations for the benefit of the Company and guaranteed by the Guarantors.

B. Administrative Agent and Lenders are willing to make the Loans and to incur Letter of Credit Obligations as provided for in the Credit Agreement, but only upon the condition, among others, that the Grantors shall have executed and delivered to Agent, for the benefit of itself and the Lenders (and the obligations to the Lenders' Affiliates in connection with Lender Rate Contracts (as defined in the Credit Agreement)), that certain Security Agreement dated as of the date hereof by and among the Company, Administrative Agent, and the other Persons party thereto (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement").

C. Pursuant to the Security Agreement, the Grantors are required to execute and deliver to Administrative Agent, for the benefit of itself and the Lenders (and the obligations to the Lenders' Affiliates in connection with Lender Rate Contracts), this Trademark Security Agreement.

### AGREEMENT

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby agree as follows:

#### ARTICLE I. DEFINED TERMS.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement and the Credit Agreement.



**ARTICLE II. GRANT OF SECURITY INTEREST AND LIEN IN TRADEMARK COLLATERAL.**

Each Grantor, in order to secure the Secured Obligations owed by such Grantor, hereby grants to Administrative Agent, on behalf of itself and the benefit of the Lenders (and the obligations to the Lenders' Affiliates in connection with Lender Rate Contracts), a continuing first priority security interest and Lien in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

- (a) all of its Trademarks, and all Trademark Licenses to which it is a party, including without limitation those referred to opposite such Grantor's name on Schedule I hereto;
- (b) all applications for registration, registrations, renewals, reissues, continuations or extensions, derivatives and modifications of the foregoing or pertaining thereto;
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- (d) all products and proceeds of and from the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License, (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License or (iii) Trademark License royalties.

**ARTICLE III. APPOINTMENT OF ADMINISTRATIVE AGENT AS ATTORNEY-IN-FACT.**

Grantors hereby irrevocably constitute and appoint Administrative Agent and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority in the name of Grantors or in its name, from time to time, in Administrative Agents' discretion, so long as any Event of Default has occurred and is continuing, to take with respect to the Trademark Collateral any and all appropriate action which Grantors might take with respect to the Trademark Collateral and to execute any and all documents and instruments which may be necessary or desirable to carry out the terms of this Trademark Security Agreement and to accomplish the purposes hereof.

**ARTICLE IV. AGREEMENT BY GRANTORS NOT TO ASSIGN OR ENCUMBER ANY OF THE TRADEMARK COLLATERAL.**

Except to the extent not prohibited in the Security Agreement or the Credit Agreement, Grantors agree not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the foregoing Trademark Collateral.

**ARTICLE V. SECURITY AGREEMENT.**

The rights, Liens and security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the Liens and security interests granted to Administrative Agent, on behalf of itself and Lenders, pursuant to the Security Agreement. The Grantors hereby acknowledge and affirm that the rights and remedies of Administrative Agent with respect to the security interest and Lien in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

**ARTICLE VI. GOVERNING LAW; WAIVER OF JURY TRIAL; SUBMISSION TO JURISDICTION; VENUE.**

THIS TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REFERENCE TO CONFLICTS OF LAW RULES (OTHER THAN SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW). THE PROVISIONS OF THE SECURITY AGREEMENT RELATING TO WAIVER OF JURY TRIAL, CONSENT TO JURISDICTION, VENUE AND ARBITRATION ARE HEREBY INCORPORATED BY REFERENCE HEREIN, MUTATIS MUTANDIS.
