RELEASE OF SECURITY INTEREST - TRADEMARKS

WHEREAS, LANGUAGE LINE, LLC., a Delaware limited liability company ("Pledgor"), and TORONTO DOMINION (TEXAS), INC., as administrative agent (in such capacity, the "Administrative Agent"), entered into certain Trademark Security Agreements (collectively, the "Security Agreements");
