

Assignor hereby irrevocably designates and appoints Assignee or its legal representatives as agents and attorneys-in-fact to act for and on behalf of Assignor, to execute and file any document and to do any other lawfully permitted act required to carry out and record this transfer and assignment to Assignee.

Said trademark and its Certificates or Registration are to be held and enjoyed by Winpak Portion Packaging, Inc. for its own use and benefit and for its successors and assigns to the full end of the present or extended term for which said Certificates of Registration have been granted, as fully and entirely as the same would have been held by Clear Lam Packaging, Inc. if this assignment and contribution had not been made.


