Pursuant to the provisions of Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA") and Section 264 of the Delaware General Corporation Law (the "DGCL"), the undersigned corporation hereby certifies that:

- (1) The name and state of organization of each of the constituent entities are:
  - (a) Skyjet.com Business Jet Systems, LLC, a Delaware limited liability company ("Skyjet"); and
  - (b) Bombardier Aerospace Corporation, a Delaware corporation ("BAC").
- (2) An Agreement and Plan of Merger between BAC and Skyjet (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by BAC and Skyjet in accordance with the provisions of Section 264 of the DGCL and Section 18-209 of the DLLCA, respectively.
- (3) The name of the surviving corporation is Bombardier Aerospace Corporation.
- (4) The certificate of incorporation of BAC shall be the certificate of incorporation of the surviving corporation.
- (5) The executed Merger Agreement is on file at an office of BAC located at 3400 Waterview Parkway, Suite 400, Richardson, Texas 75080.
- (6) A copy of the Merger Agreement will be furnished by BAC, on request and without cost, to any member or interest holder of Skyjet and any stockholder of BAC.
- (7) The effective time of the merger being consummated hereby shall be the time of filing of this Certificate of Merger with the Secretary of State of the State of Delaware.
