ASSIGNMENT AGREEMENT

THIS AGREEMENT, effective as of the day and year last written below, is by and between FELLOWES, INC. (hereafter "Fellowes"), an Illinois Corporation, with a principal place of business at 1789 Norwood Avenue, Itasca, Illinois 60143 and FELLOWES RESEARCH GROUP, INC. (hereafter "FRGI"), an Ohio Corporation, with a principal place of business at 3299 Willowbrook Drive, Cleveland, Ohio 44124.

WHEREAS, Fellowes has adopted, registered, owns and is using throughout the world the name and mark FELLOWES; and

WHEREAS, FRGI has adopted, owns, and is using the mark FELLOWES RESEARCH (hereafter the "Mark") and is the owner of US Application Serial No. 76/122,580 for the Mark; and

WHEREAS, the US Patent and Trademark Office approved US Application Serial No. 76/122,580 for publication for opposition, and Fellowes filed various extensions of time to oppose US Application Serial No. 76/122,580; and

WHEREAS, the parties wish to resolve any potential dispute and/or Opposition Proceeding on an amicable basis;

NOW, THEREFORE, in exchange for the consideration listed below and other valuable consideration, the parties hereby agree as follows:

1. **ASSIGNMENT**: FRGI hereby assigns, sells, transfers and conveys to Fellowes all right, title and interest in and to the Mark, including but not limited to all common law rights and the right to pursue legal actions for past infringement of the Mark and related damages, together with the goodwill of the business symbolized by the Mark and any registrations thereof or applications therefor.
2. **EFFECTIVE DATE OF ASSIGNMENT**: The foregoing Assignment shall be effective on the registration date or abandonment date of US Application Serial Number 76/122,580, whichever event first occurs ("Assignment Date"). In the event that US Application Serial Number 76/122,580 is divided into two or more applications, this Assignment shall be divided accordingly and the Assignment Date shall be determined separately for each divided application as set forth in the preceding sentence. FRGI agrees not to assign, sell, transfer and/or convey to any third party any right, title, and/or interest in and to the Mark or Serial Number 76/122,580 (or any related applications) prior to the Assignment Date.
3. **PAYMENT**: Within thirty (30) days of the Assignment Date (or, if US Application Serial Number 76/122,580 is divided into two or more applications, the last Assignment Date of any divided applications), Fellowes shall deliver to FRGI via overnight courier a draft in the amount of eight hundred fifty US dollars (US \$850).
