CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION

First: That the Board of Directors of Spontex, Inc. by unanimous written consent duly adopted resolutions setting forth a proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and submitting it to the sole stockholder of said corporation for consideration.
