EXHIBIT A

Trademark Assignment

This Trademark Assignment ("Trademark Assignment") is made effective and entered into as of this 23rd day of September, 2004 ("Effective Date"), by and between Stearns Packaging Corporation, a Wisconsin corporation, having an address at 4200 Sycamore Avenue, Madison, WI 53704 ("Stearns Packaging") and Sears Brands LLC, an Illinois limited liability company, having an address at 3333 Beverly Road, B6-223A, Hoffman Estates, Illinois 60179 ("Sears Brands"). Stearns Packaging and Sears Brands hereinafter may be referred to individually as a "party" and collectively as the "parties."

RECITALS

A. Since at least as early as January 18, 2002, Stearns Packaging has used the trademark, trade name, trade style, and/or designation PLUS (the "Mark") for laundry detergent.

B. Stearns Packaging is the owner of U.S. Trademark Registration No. 2,603,010 issued July 30, 2002 for the mark PLUS for "laundry detergent" in International Class 03 (the "Registration").

C. Stearns Packaging and Sears Brands' Related Party, Sears Intellectual Property Management Company, an Illinois corporation, having an address at 3333 Beverly Road, B6-223A, Hoffman Estates, Illinois 60179, have entered into an Agreement executed and delivered concurrently herewith, pursuant to which Stearns Packaging agrees to transfer to Sears Brands all right, title and interest in and to the Registration and the Mark and all goodwill associated therewith and to which this Trademark Assignment is an attached Exhibit (the "Agreement").

D. Capitalized terms that are used in this Trademark Assignment without separate definition shall have the meanings specified in the Agreement.

NOW THEREFORE, in consideration the foregoing Recitals, which are incorporated by reference into this Trademark Assignment, the mutual covenants and promises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Agreement, which are incorporated herein by this reference, the parties agree as follows:

ASSIGNMENT

1. Stearns Packaging hereby assigns, transfers, and delivers to Sears Brands all of its rights, title and interest in and to the Registration and Mark together with all of the goodwill associated with and identified thereby, and all proceeds thereof, including, without limitation, any and all causes of action for infringement thereof and any and all royalties for any licenses thereof (collectively, the "Assets"), the Assets to be held and enjoyed by Sears Brands, for its own use, and for the use of its Related Parties and/or other successors, assigns or other legal representatives, as fully and entirely as the same would have been enjoyed by Stearns Packaging, had this Trademark Assignment not been made.

2. Stearns Packaging agrees that the Assets as defined herein include all rights to sue, bring actions for and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Registration or Mark, including without limitation, the right to sue third parties for past infringement, dilution, cyber-piracy, unfair competition and counterfeiting of the Registration or Mark, and to recover and

hold all damages, profits and other compensation arising from such third party's unlawful acts which may have occurred prior to the Effective Date of this Trademark Assignment.

3. Nothing in this Trademark Assignment shall be deemed to limit, expand or otherwise modify any representation, warranty or covenant set forth in the Agreement.

4. This Trademark Assignment may be executed in counterparts and each taken together shall constitute one and the same document. Likewise, this Trademark Assignment may be executed by facsimile signatures, each of which shall constitute an original signature. The person signing below on behalf of Stearns Packaging represents, warrants and covenants that he/she has the authority to execute this Trademark Assignment on behalf of Stearns Packaging and has full legal power and authority to enter into and perform this Trademark Assignment in accordance with its terms.
