ASSIGNMENT OF TRADEMARKS

WHEREAS, Pinnacle One Partners, L.P., a Delaware limited partnership ("Pinnacle"), entered into a Stock Purchase Agreement, dated January 15, 2004 (the "Stock Purchase Agreement"), between Pinnacle and Consolidated Communications Acquisition Texas, Inc. (formerly known as Homebase Acquisition Texas Corp.) ("Buyer"), pursuant to which Pinnacle sold its shares of the common stock of TXU Communications Ventures Company (now known as Consolidated Communications Ventures Company) ("Consolidated Communications");

WHEREAS, pursuant to the Stock Purchase Agreement, Pinnacle and Buyer intended that the Marks (as hereinafter defined) be conveyed to Buyer as assets of Consolidated Communications;

WHEREAS, Pinnacle and Buyer subsequently discovered that TXU Investment Company (formerly known as TXU Communications Company), a corporation organized and existing under the laws of the State of Texas, having a principal place of business located at 1601 Bryan Street, Dallas, Texas 75201 (hereinafter "Assignor"), owns the trademarks and service marks set forth on the attached Schedule (hereinafter the "Marks");

WHEREAS, TXU Investment Company desires to assign, and Consolidated Communications, a corporation organized and existing under the laws of the State of Delaware, having a principal place of business located at 121 South 17th Street, Mattoon, Illinois 61938 (hereinafter "Assignee"), desires to acquire, the Marks and the goodwill of the business pertaining thereto along with the registrations and applications therefor;


WHEREAS, the assignment of said Marks, and registrations thereof and applications therefor, be made of record in the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, Assignor assigns to Assignee all right, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, together with that portion of Assignor's business on or in connection with which it has a bona fide intent to use the Marks, and all of Assignor's rights therein, and the registrations thereof and applications therefor, and all rights to damages and profits, due or accrued, arising out of past infringements of said trademarks, and the right to sue for and recover the same.


