NUNC PRO TUNC ASSIGNMENT

WHEREAS, pursuant to the STOCK PURCHASE AGREEMENT, dated April 4, 2003 (the "Agreement") by and among Relocation Resources International, Inc., a Delaware corporation with a place of business at 120 Longwater Drive, Norwell, Massachusetts 02061 ("RRI"), the Stockholders of RRI, and Weichert Relocation Co., Inc., a New Jersey corporation with a place of business at 1625 State Route 10, Morris Plains, New Jersey 07950, Weichert Relocation Co., Inc. acquired from RRI all its right, title and interest to the service mark "**RELOCATION RESOURCES**" (the "Mark") throughout the United States, together with all the goodwill of the business associated with and symbolized by the Mark, for the services identified in RRI's U.S. Trademark Registration No. 1191319 for "Providing Pertinent Information to Corporate Employees Engaged in Relocating from One Area to Another with Respect to Real Estate Purchases and Financing, Demographic Data, Taxes, Climate, Schools, Churches and the Like (the "Registration"); and

WHEREAS, as a nunc pro tunc assignment to be effective as of the April 4, 2003 date of the Agreement, RRI hereby desires to execute a written assignment of its Mark and Registration to Weichert Relocation Resources Inc. (formerly named Weichert Relocation Co. Inc.), a New Jersey corporation with a place of business at 1625 State Route 10, Morris Plains, NJ 07950;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, effective as of April 4, 2003, **RRI (ASSIGNOR)** hereby assigns to **Weichert Relocation Resources Inc. (ASSIGNEE)** all its right, title and interest to the Mark throughout the United States, together with all the goodwill of the business associated with the Mark and symbolized by it, together with its Registration to the Mark, and its right to sue for and collect damages for past and future infringements of the Mark.
