NUNC PRO TUNC ASSIGNMENT

WHEREAS, pursuant to a STOCK PURCHASE AGREEMENT dated April 4, 2003 (the "Agreement") by and among Relocation Resources International, Inc., a Delaware corporation with a place of business at 120 Longwater Drive, Norwell, Massachusetts 02061 ("RRI"), the Stockholders of RRI, and Weichert Relocation Co. Inc., a New Jersey corporation with a place of business at 1625 State Route 10, Morris Plains, New Jersey 07950, Weichert Relocation Co. Inc. acquired from RRI all its right, title and interest to the service mark "**RELOCATION RESOURCES**" (the "Mark") throughout the United States, together with all the goodwill of the business associated with and symbolized by the Mark, for the services identified in RRI's U.S. Trademark Registration No. 1191319 (the "Registration") for "Providing Pertinent Information to Corporate Employees Engaged in Relocating from One Area to Another with Respect to Real Estate Purchases and Financing, Demographic Data, Taxes, Climate, Schools, Churches and the Like (the "Registration"); and

WHEREAS, Weichert Relocation Co. Inc. obtained a written nunc pro tunc assignment of the Mark and the Registration from RRI, effective as of April 4, 2003;


WHEREAS, on or about April 16, 2003, Weichert Relocation Co. Inc. and Weichert Co., a New Jersey corporation with a place of business at 1625 State Route 10, Morris Plains, NJ 07950, agreed that, effective April 4, 2003, all of Weichert Relocation Co. Inc.'s right, title and interest to the Mark and Registration, together with the goodwill associated with the business and symbolized by the Mark and Registration, were in fact then assigned to Weichert Co., but without having executed a formal United States mark assignment document;

WHEREAS, Weichert Relocation Co. Inc. (now named Weichert Relocation Resources Inc.) and Weichert Co. now desire such formal United States assignment in order to record the same in the United States Patent and Trademark Office;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor **Weichert Relocation Co. Inc., now named Weichert Relocation Resources Inc.**, hereby confirms the aforesaid assignment and does hereby assign, nunc pro tunc, as of April 4, 2003, to Assignee **Weichert Co.**, all its right, title and interest in and to the Mark and the Registration throughout the United States, together with all the goodwill of the business connected with and symbolized by the Mark and the Registration, as well as all rights to injunctive relief, damages or profits, due or accrued, arising out of past infringement of the Mark or the Registration or injury to the goodwill, and the right to sue for and collect the same in its, the Assignee's, own name.

As of JANUARY 12 2005, Weichert Relocation Resources Inc. and Weichert Co. have caused this Assignment to be executed by its duly authorized officers.
