**THIS DEED OF ASSIGNMENT** is made this 16th day of June 2004

**BETWEEN**

(1) "the Assignor" **FOSBEL INTELLECTUAL AG** whose registered office is at Seedamm Business Center, Churerstrasse 135, 8808 Pfäffikon, Switzerland; (formerly of Bahnhofstrasse 16, 8808 Pfäffikon, Switzerland)

**AND**

(2) "the Assignee" **HOTWORK-USA LLC** whose registered office is at 223 Goldrush Road, Lexington, Kentucky 405093, USA

**WHEREAS**

- (A) The Assignor is the proprietor of the trade mark set out in the Schedule hereto ("the Trade Mark") and the Assignor has agreed to assign the Trade Mark to the Assignee.
- (B) It is the intention of the parties that this document should be executed as a deed.

**NOW THEREFORE IT IS AGREED**

- 1. The Assignor hereby assigns to the Assignee all right title and interest in and to the Trade Mark(s) together with the goodwill of the business relating to the goods in respect of which the Trade Mark(s) is (are) registered, and all benefit of the applications for those of the Trade Mark (s) which are not yet registered to the intent that upon registration this Agreement shall operate to vest them in the Assignee together with the goodwill of the businesses relating to the goods in respect of which they are registered.
- 2. The Assignee undertakes and agrees to execute all documents and do all such acts and things as may be necessary to give legal effect to the assignments hereunder, the costs of which shall be borne by the Assignee in total.
- 3. This Agreement shall be governed by and construed and interpreted in accordance with the laws of England. Any litigation relating to the conclusion validity interpretation or performance of this Agreement or of subsequent contracts or operations derived herefrom as well as any other litigation concerning or related to this Agreement without any exception shall be submitted to the exclusive jurisdiction of the English Courts.
