portions thereof regarding any or all of the aforementioned trademark/service mark applications and registrations, as required by ASSIGNEE in the future.

ASSIGNOR of the aforesaid MARKS hereby agrees to waive all rights and privileges to attack the registration of the aforesaid MARKS which ASSIGNOR has assigned as against anyone claiming a right under any or all of the aforementioned MARKS under ASSIGNOR's assignment or grant.

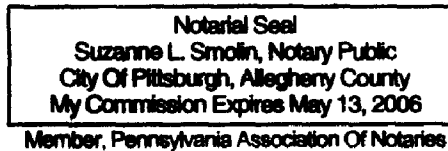
