## TRADEMARK ASSIGNMENT

This Assignment (this "Assignment") is made and entered into as of May 31, 2004 by and between **Fresenius Kabi AB** (f/k/a Fresenius Kabi Nutrition AB), a Swedish company, having its place of business in Uppsala, Sweden, ("Assignor") and **Hospira, Inc.**, a Delaware corporation. Assignor does hereby sell, assign, transfer and set over to Assignee all of Assignor's right, title and interest in, to and under the Mark and its registration, and the goodwill of the business symbolized thereby, for Assignee's own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made.

Assignor does further agree to execute and deliver any further applications, assignments and documents prepared by the Assignee, and to perform such other acts as may be deemed necessary by Assignee, its successors and assigns, and nominees, to allow Assignee to record the assignment and thus secure its interest as aforesaid and to transfer or maintain trademark registration in the United States.

This Assignment shall be governed by the applicable laws of the United States and the State of North Carolina.

This Assignment shall be binding upon Assignor and its successors and assigns and shall inure to the benefit of Assignee and its successors and assigns.


