Trademark Security Agreement

Trademark Security Agreement, dated as of June 4, 2004 by MAAX CORPORATION ("Borrower") and each Guarantor listed on Schedule II hereto (collectively, the "Original Guarantors," together with Borrower, the "Pledgors"), in favor of ROYAL BANK OF CANADA, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent") dated as of the date hereof among the Borrower, the Guarantors party thereto, Goldman Sachs Credit Partners L.P., Royal Bank of Canada, Royal Bank of Canada, acting through its business group RBC Capital Markets, Merrill Lynch & Co., Merrill Lynch, Pierce, Fenner & Smith Incorporated and the Lenders from time to time party thereto.

WITNESSETH:

WHEREAS, Pledgors are party to either the U.S. Security Agreement or the Canadian Security Agreement of even date herewith (collectively, the "Security Agreements") in favor of the Collateral Agent pursuant to which the Pledgors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Collateral Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Pledgors hereby agree with the Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreements and used herein have the meaning given to them in the Security Agreements.

SECTION 2. Grant of Security Interest in Trademark Collateral. Each Pledgor hereby pledges and grants to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the following Security Agreement Collateral of such Pledgor:

- (a) Trademarks of such Pledgor listed on Schedule I attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

SECTION 3. Security Agreements. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the respective Security Agreement and Pledgors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the respective Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreements, the provisions of the respective Security Agreement shall control. For the avoidance of doubt, the grants hereunder by Pledgors party to the U.S. Security Agreement and the relationship hereunder between such Pledgors and Collateral Agent shall be subject to such agreement including the governing law provision thereof. For the avoidance of doubt, the grants hereunder by

Pledgors party to the Canadian Security Agreement and the relationship hereunder between such Pledgors and Collateral Agent shall be subject to such agreement including the governing law provisions thereof.

SECTION 4. Termination. Upon the full payment of the Obligations (other than contingent obligations that constitute indemnification obligations that survive termination of the Credit Agreement), the Collateral Agent shall execute, acknowledge, and deliver to the Pledgor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks under this Trademark Security Agreement.
