**CERTIFICATE OF OWNERSHIP AND MERGER**

Pursuant to § 253 of the Delaware General Corporation Law

Anthony, Inc., a Delaware corporation, desiring to merge Ardco Holdings, Inc., a Delaware corporation, pursuant to the provisions of § 253 of the Delaware General Corporation Law, hereby certifies as follows:

1. Anthony, Inc. (the "Surviving Corporation") is a corporation organized and validly existing under the laws of the State of Delaware; its Certificate of Incorporation was filed in the office of the Secretary of State of Delaware on November 23, 1998.
2. Ardco Holdings, Inc. (the "Subsidiary") is a corporation organized and validly existing under the laws of the State of Delaware. Its Certificate of Incorporation was filed in the office of the Secretary of State of Delaware on March 22, 2002.
3. On March 28, 2003, the Surviving Corporation lawfully owned all of the issued and outstanding capital stock of the Subsidiary, and on that date the Board of Directors of the Surviving Corporation, by resolution duly adopted by unanimous written consent, determined to merge the Subsidiary into the Surviving Corporation and to assume all of the Subsidiary's obligations, such merger and assumption of obligations to be effective upon the filing of this Certificate of Ownership and Merger; said resolution reads as follows:

RESOLVED, that the Corporation, being the owner of all of the issued and outstanding capital stock of Ardco Holdings, Inc. does hereby authorize and approve the merger of Ardco Holdings, Inc. with and into the Corporation, with the Corporation being the surviving corporation, and to assume all of the Ardco Holdings, Inc.'s obligations, effective upon the filing of the Certificate of Ownership and Merger related to the merger with the Secretary of State of the State of Delaware; and that the proper officers of the

Corporation are authorized and directed to make and execute, in the name of the Corporation and under its corporate seal, and to file with the Secretary of State of Delaware, a Certificate of Ownership and Merger setting forth therein a copy of this resolution, pursuant to the provisions of § 253 of the Delaware General Corporation Law, such officers being further authorized and directed to execute such other documents and to take such other actions as they may deem necessary or appropriate to consummate the merger provided for by this resolution.
