REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of January 20, 2005 by COMERICA BANK, predecessor in interest to Imperial Bank ("LENDER") in favor of HEALTHTALK, INC., a Delaware corporation, with its principal place of business at 100 4th Avenue North, Suite 460, Seattle, WA 98109 ("COMPANY").

Recital

WHEREAS, COMPANY assigned a security interest in the trademarks on Exhibit A and certain other trademarks and service marks (collectively, the "Trademarks"), to LENDER or its predecessors in interest either 1) under an Intellectual Property Security Agreement dated as of November 15, 2000, and recorded with the U.S. Patent and Trademark Office on December 1, 2000 at Reel Number 002186 and Frame Number 0270, or 2) under an Intellectual Property Security Agreement dated as of September 14, 2004, and recorded with the U.S. Patent and Trademark Office on September 28, 2004 at Reel Number 002947 and Frame Number 0658 (collectively, the "Security Agreement"); and

WHEREAS, COMPANY has satisfied its obligations under the Security Agreement, and LENDER agrees to release all interest that LENDER may have in the Trademarks.

Agreement

Now therefore, LENDER agrees that it hereby releases its security interest in the Trademarks, and releases any other right, title and interest granted to LENDER pursuant to the Security Agreement, and reassigns to COMPANY, without warranty or recourse, all right, title and interest (if any) of LENDER in the Trademarks. LENDER further agrees to execute and deliver to COMPANY any and all further documents or instruments and do any and all further acts which COMPANY reasonably requests in order to confirm this Reassignment and Release of Security Interest, at COMPANY's sole cost and expense. This Reassignment and Release of Security Interest shall be binding upon LENDER's legal representatives, assigns and successors.
